Aurelia:

Beginning on 1st Street at the west corporation line; thence southeasterly on 1st Street to the east corporation line.

Beginning again at the east corporation line of Aurelia, connecting with 1st Street; thence in an easterly and southeasterly direction along the north side of the Illinois Central Railroad and substantially parallel thereto through Sections 11, 12, and 13-T91N-R39W, Cherokee County (west line of Section 18-T91N-R38W, Buena Vista County).

Due to a review of our Primary Road System records, Iowa 7, in Cherokee County should be deleted and the new description should be officially included into the primary system.

Beginning again at the east corporation line of the City of Aurelia, connecting with an unnamed street; thence in an easterly and southeasterly direction along the north side of the Illinois Central Railroad and substantially parallel thereto through Sections 11, 12, and 13-T91N-R39W, Cherokee County (west line of Section 18-T91N-R38W, Buena Vista County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 7 in Cherokee County, Iowa.
