Beginning on the south corporation line of Pomeroy, connecting with East Street; thence south following substantially the section line of Sections 7 and 18-T89N-R32W to a point approximately 700 feet north of the SW Corner Section 18-T89N-R32W; thence curving in a southeasterly direction to a point approximately 700 feet east of the SW Corner Section 18-T89N-R32W; thence east following substantially the section line through Sections 19, 20, 21, 22, 23, and 24-T89N-R32W; thence east following substantially the section line of Sections 19, 20, 21, 22, 23, and 24-T89N-R31W to a point approximately 500 feet east of the N $\frac{1}{4}$ Corner Section 24-T89N-R31W; thence in a northeasterly direction through the south part of Section 13-T89N-R31W to the Calhoun-Webster County line at a point approximately 700 feet north of the southeast corner of Section 13-T89N-R31W, Calhoun County (SW Corner of Section 18-T89N-R30W, Webster County).
