New Description – Iowa 10 and its extensions in Clay County described as follows:

Beginning on the Clay–O'Brien County line at a point approximately $\frac{1}{4}$ mile south of the NW Corner of Section 31–T94N–R38W, Clay County (NE Corner of Section 36–T94N–R39W, O'Brien County); thence in an easterly direction through the north part of Sections 31 and 32–T94N–R38W to the west corporation line of Peterson connecting with Front Street.

Peterson:

Beginning on the west corporation line connecting with Front Street; thence southeasterly on Front Street to 2nd Street; thence easterly and northeasterly on 2nd Street to the east corporation line.

Beginning again on the east corporation line of Peterson connecting with 2nd Street; thence in a northeasterly, easterly, northeasterly direction through the north part of Sections 33, 34, and 35–T94N–R38W to a point approximately $\frac{1}{4}$ mile east of the NW Corner of Section 35–T94N–R38W; thence east following substantially the section line of Sections 35 and 36–T94N–R38W and Sections 31, 32, 33, 34, 35, and 36–T94N–R37W (north junction of US 71) at a point near the N $\frac{1}{4}$ Corner of Section 36–T94N–R37W; thence southerly following substantially the center section line of Section 36–T94N–R37W to the Clay–Buena Vista County line at a point near the S $\frac{1}{4}$ Corner of Section 36–T94N–R37W, Clay County (N $\frac{1}{4}$ Corner Section 1–T93N–R37W, Buena Vista County).

Beginning on the Clay-O'Brien County line at a point approximately $\frac{1}{4}$ mile south of the NW Corner of Section 31-T94N-R38W, Clay County (NE Corner of Section 36-T94N-R39W, O'Brien County); thence in an easterly direction through the north part of Sections 31 and 32-T94N-R38W to the west corporation line of the City of Peterson connecting with an unnamed street.

Peterson:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly, easterly, and northeasterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Peterson connecting with an unnamed street; thence in a northeasterly, easterly, northeasterly direction through the north part of Sections 33, 34, and 35-T94N-R38W to a point approximately $\frac{1}{4}$ mile east of the NW Corner of Section 35-T94N-R38W;

thence easterly following substantially the section line of Sections 35 and 36-T94N-R38W and Sections 31, 32, 33, 34, 35, and 36-T94N-R37W (north junction of US 71) at a point near the N $\frac{1}{4}$ Corner of Section 36-T94N-R37W; thence southerly following substantially the center section line of Section 36-T94N-R37W to the Clay-Buena Vista County line at a point near the S $\frac{1}{4}$ Corner of Section 36-T94N-R37W, Clay County (N $\frac{1}{4}$ Corner Section 1-T93N-R37W, Buena Vista County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 10 in Clay County, Iowa.

Beginning again on the east corporation line of the City of Peterson connecting with an unnamed street; thence in a northeasterly, easterly, northeasterly direction through the north part of Sections 33, 34, and 35-T94N-R38W to a point approximately ¼ mile east of the NW Corner of Section 35-T94N-R38W; thence easterly following substantially the section line of Sections 35 and 36-T94N-R38W and Sections 31, 32, 33, 34, 35, and 36-T94N-R37W (north junction of US 71) at a point near the N ¼ Corner of Section 36-T94N-R37W; thence southerly following substantially the center section line of Section 36-T94N-R37W to the Clay-Buena Vista County line at a point near the S ¼ Corner of Section 36-T94N-R37W, Clay County (N ¼ Corner Section 1-T93N-R37W, Buena Vista County).

Beginning at a point approximately 600 feet west of the N ¼ Corner of Section 36-T94N-R37W; thence east to a point approximately 200 feet west of the N ¼ Corner of Section 36-T94N-R37W; thence curving in a northeasterly direction to a point approximately 200 feet north of the N ¼ Corner of Section 36-T94N-R37W.

Beginning again on the east corporation line of the Town of Peterson, connecting with Second Street; thence in a northeasterly, easterly and northeasterly direction through Section 33, 34 and 35-T94N-R38W to a point approximately $\frac{1}{4}$ mile east of the NW Corner of Section 35-T94N-R38W; thence east following substantially the section line to a point approximately 600 feet west of the N $\frac{1}{4}$ Corner of Section 36-T94N-R37W; thence curving in a southeasterly direction to a point approximately 600 feet south of the N $\frac{1}{4}$ Corner of Section 36-T94N-R37W; thence south to the Clay-Buena Vista County line at a point near the S $\frac{1}{4}$ Corner of Section 36-T94N-R37W, Clay County (N $\frac{1}{4}$ Corner of Section 1-T93N-R37W, Buena Vista County).
