DISCUSSION/BACKGROUND:

Iowa 111 begins on Main Street at the Chicago and Northwestern Railroad in Kanawha; thence travels north, northwest, north, northeast, north and west and ends on Bush Avenue at 3rd Street in Woden.

Transfer of Jurisdiction agreement number TJ-111-1 (6) --2M-41, between the Iowa Department of Transportation and Hancock County as well as the cities of Kanawha, Britt, Crystal Lake and Woden, transferred Iowa 111 to local jurisdiction on December 31, 1990.

The official description of Iowa 111 should be deleted to reflect this transfer.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Iowa 111 in Hancock County from the Primary Road System.

Remove Iowa 111 and its extensions in Hancock County as follows:

Kanawha:

Beginning on Main Street at the Chicago and Northwestern Railroad; thence north on Main Street to the north corporation line.

Beginning on the north corporation line of Kanawha, connecting with Main Street; thence north following substantially the section line of Sections 22, 15, 10 and 3-T94N-R25W and Sections 34, 27, 22 and 15-T95N-R25W to a point approximately 2,000 feet south of the NW

Corner of Section 15-T95N-R25W; thence continuing in a northwesterly direction through Sections 16 and 9-T95N-R25W to a point approximately 3,100 feet south of the N $\frac{1}{4}$ Corner of Section 9-T95N-R25W; thence north following substantially the center section line through Sections 9 and 4-T95N-R25W and Section 33-T96N-R25W to the south corporation line of Britt connecting with 1st Avenue SW.

Britt:

Beginning on 1st Avenue SW at the south corporation line; thence north on 1st Avenue SW to Diagonal Street; thence northeast on Diagonal Street to Main Avenue South; thence north on Main Avenue South to Main Avenue North; thence north on Main Avenue North to the north corporation line.

Beginning again on the north corporation line of Britt connecting with Main Avenue N.; thence curving northwesterly and northerly to a point near the N $\frac{1}{4}$ Corner of Section 28-T96N-R25W; thence in a northeasterly direction through Section 21-T96N-R25W to a point a short distance south of the E $\frac{1}{4}$ Corner of Section 21-T96N-R25W; thence north following substantially the section line of Sections 22, 15, 10 and 3-T96N-R25W and Sections 34, 27, 22 and 15-T97N-R25W to the south corporation line of Crystal Lake connecting with Summit Avenue.

Crystal Lake:

Beginning on Summit Avenue at the south corporation line; thence north and northwest on Summit Avenue to the west corporation line.

Beginning again on the west corporation line of Crystal Lake, connecting with Summit Avenue; thence west following substantially the section line of Sections 16, 17, and 18-T97N-R25W and Sections 13, 14, and 15-T97N-R26W to the south corporation line of Woden connecting with an unnamed street.

Woden:

Beginning on an unnamed street at the south corporation line; thence northeast on unnamed street to Bush Avenue; thence north on Bush Avenue to 3rd Street.

New Description – Iowa 111 and its extensions in Hancock County described as follows:

Kanawha:

Beginning on Main Street at the Chicago and Northwestern Railroad; thence north on Main Street to the north corporation line.

Beginning on the north corporation line of Kanawha, connecting with Main Street; thence north following substantially the section line of Sections 22, 15, 10 and 3-T94N-R25W and Sections 34, 27, 22 and 15-T95N-R25W to a point approximately 2,000 feet south of the NW Corner of Section 15-T95N-R25W; thence continuing in a northwesterly direction through Sections 16 and 9-T95N-R25W to a point approximately 3,100 feet south of the N $\frac{1}{4}$ Corner of Section 9-T95N-R25W; thence north following substantially the center section line through Sections 9 and 4-T95N-R25W and Section 33-T96N-R25W to the south corporation line of Britt connecting with 1st Avenue SW.

Britt:

Beginning on 1st Avenue SW at the south corporation line; thence north on 1st Avenue SW to Diagonal Street; thence northeast on Diagonal Street to Main Avenue South; thence north on Main Avenue South to Main Avenue North; thence north on Main Avenue North to the north corporation line.

Beginning again on the north corporation line of Britt connecting with Main Avenue N; thence curving northwesterly and northerly to a point near the N $\frac{1}{4}$ Corner of Section 28-T96N-R25W; thence in a northeasterly direction through Section 21-T96N-R25W to a point a short distance south of the E $\frac{1}{4}$ Corner of Section 21-T96N-R25W; thence north following substantially the section line of Sections 22, 15, 10 and 3-T96N-R25W and Sections 34, 27, 22 and 15-T97N-R25W to the south corporation line of Crystal Lake connecting with Summit Avenue.

Crystal Lake:

Beginning on Summit Avenue at the south corporation line; thence north and northwest on Summit Avenue to the west corporation line.

Beginning again on the west corporation line of Crystal Lake, connecting with Summit Avenue; thence west following substantially the section line of Sections 16, 17, and 18-T97N-R25W and Sections 13, 14, and 15-T97N-R26W to the south corporation line of Woden connecting with an unnamed Street.

Woden:

Beginning on an unnamed street at the south corporation line; thence northeast on unnamed street to Bush Avenue; thence north on Bush Avenue to 3rd Street.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 111 in Hancock County should be deleted, and the new description added should be officially included into the Primary Road System.

Iowa 111 begins in Kanawha traveling in a northerly and westerly direction terminating in Woden via the Cities of Britt and Crystal Lake, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 111 and its extensions in Hancock County as follows:

Kanawha:

Beginning at a point approximately 600 feet south of Second Street thence north to the north corporation line connecting with an unnamed street.

Beginning on the north corporation line of the City of Kanawha, connecting with unnamed street; thence north following substantially the section line of Sections 22, 15, 10 and 3-T94N-R25W and Sections 34, 27, 22 and 15-T95N-R25W to a point approximately 500 feet north of the W $\frac{1}{4}$ Corner of Section 15-T95N-R25W thence in a northerly direction to a point approximately 2000 feet south of the NW corner of Section 15-T95N-R25W; thence continuing in a northwesterly direction through Sections 16 and 9-T95N-R25W to a point approximately 3100 feet south of the N $\frac{1}{4}$ Corner of Section 9-T95N-R25W; thence north following

substantially the center section line through Sections 9 and 4-T95N-R25W and Section 33-T96N-R25W to the south corporation line of the City of Britt connecting with an unnamed street.

Britt:

Beginning on the south corporation line connecting with an unnamed street; thence northerly, northeasterly, northerly to the north corporation line.

Beginning again on the north corporation line of the City of Britt connecting with unnamed street; thence curving northwesterly and northerly to a point near the N $\frac{1}{4}$ Corner of Section 28-T96N-R25W; thence in a northeasterly direction through Section 21-T96N-R25W to a point a short distance south of the E $\frac{1}{4}$ Corner of Section 21-T96N-R25W; thence north following substantially the section line of Sections 22, 15, 10 and 3-T96N-R25W and Sections 34, 27, 22 and 15-T97N-R25W to the south corporation line of the City of Crystal Lake connecting with unnamed street.

Crystal Lake:

Beginning on the south corporation line connecting with an unnamed street thence northerly and northwesterly to the west corporation line connecting with an unnamed street.

Beginning again on the west corporation line of the City of Crystal Lake, connecting with an unnamed street; thence west following substantially the section line of Sections 16, 17, and 18-T97N-R25W and Sections 13, 14, and 15-T97N-R26W to the south corporation line of the City of Woden connecting with an unnamed street.

Woden:

Beginning on the south corporation line connecting with an unnamed street; thence northwesterly and northerly to the center of Third Street.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa, 111 in Hancock County, Iowa.

Beginning again on the north corporation line of the Town of Britt connecting with Main Street; thence west to a point near the center of Section 28-T96N-R25W; thence north to a point near the N $\frac{1}{4}$ Corner of Section 28-T96N-R25W; thence in a northeasterly direction to a point a short distance south of the E $\frac{1}{4}$ Corner of Section 21-T96N-R25W; thence north following substantially the section line to the south corporation line of the Town of Crystal Lake connecting with Summit Avenue.

Beginning again on the west corporation line of the Town of Crystal Lake, connecting with an unnamed street; thence west following substantially the section line to the south corporation line of the Town of Woden.
