Beginning on the Carroll-Crawford County line at a point near the NW Corner Section 19-T82N-R36W, Carroll County (NE Corner 24--T82N-R37W, Crawford County); thence east following substantially the section line of said Section 19 to the west corporation line of Manning, connecting with 6th Street.

Manning:

Beginning on 6th Street at the west corporation line; thence east on 6th Street to the east corporation line.

Beginning again at the east corporation line of Manning, connecting with 6th Street; thence east following substantially the section line of Sections 21, 22, 23 and 24-T82N-R36W, and Sections 19, 20 (west junction US 71), 21, 22, 23 (east junction US 71), and 24-T82N-R35W and Sections 19-T82N-R34W; thence curving southeasterly through Section 20-T82N-R34W to the west corporation line of Dedham connecting with an unnamed street.

Dedham:

Beginning on an unnamed street at the west corporation line; thence southeasterly on unnamed street to the south corporation line.

Beginning again at the south corporation line of Dedham, connecting with an unnamed street; thence in a southeasterly direction through Sections

20, 21, 28, 27 and 26-T82N-R34W to a point approximately 275 feet east of the SW Corner Section 26-T82N-R34W; thence east following substantially the section line of Section 35 and 36-T82N-R34W and Sections 31, 32, and 33-T82N-R33W to a point approximately 2,000 feet east of the NW Corner of said Section 33; thence curving in a southeast direction through said Section 33 to the west corporation line of Coon Rapids, connecting with an unnamed street.

Coon Rapids:

Beginning on an unnamed street at the west corporation line; thence southeast on unnamed street to the south corporation line (Carroll-Guthrie County line).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Iowa 141 in Carroll County should be deleted and the new description added should be officially included into the Primary Road System.

Iowa 141 begins at the Carroll-Crawford County line 1 mile west of Manning and travels in an easterly and southeasterly direction through Coon Rapids at the Carroll-Guthrie County line via the Cities of Manning and Dedham, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Iowa 141 and its extensions in Carroll County as follows:

Beginning on the Carroll–Crawford County line at a point near the NW Corner Section 19–T82N–R36W, Carroll County (NE Corner Section 24–T82N–R37W, Crawford County); thence east following substantially the section line of said Section 19 to the west corporation line of the City of Manning, connecting with an unnamed street.

Manning:

Beginning at the west corporation line, connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of the City of Manning, connecting with an unnamed street; thence east following substantially the section line of Sections 21, 22, 23 and 24–T82N–R36W, and Sections 19, 20 (west junction US 71), 21, 22, 23 (east junction US 71), and 24–T82N–R35W and Sections 19–T82N–R34W; thence curving southeasterly through Section 20–T82N–R34W to the west corporation line of the City of Dedham connecting with an unnamed street.

Dedham:

Beginning at the west corporation line connecting with an unnamed street; thence southeasterly to the south corporation line connecting with an unnamed street.

Beginning again at the south corporation line of the City of Dedham, connecting with an unnamed street; thence in a southeasterly direction through Sections 20, 21, 28, 27 and 26–T82N–R34W to a point approximately 275 feet east of the SW Corner Section 26–T82N–R34W; thence easterly following substantially the section line of Section 35 and 36–T82N–R34W and Sections 31, 32, and 33–T82N–R33W to a point

approximately 2,000 feet east of the NW Corner of said Section 33; thence curving in a southeasterly direction through said Section 33 to the west corporation line of the City of Coon Rapids, connecting with an unnamed street.

Coon Rapids:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly to the south corporation line connecting with an unnamed street. (Carroll/Guthrie County line)

NOW THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 141 in Carroll County, Iowa.

Beginning again at the east corporation line of the City of Manning, connecting with an unnamed street; thence east following substantially the section line of Sections 21, 22, 23 and 24–T82N–R36W, and Sections 19, 20 (west junction US 71), 21, 22, 23 (east junction US 71), and 24–T82N–R35W and Sections 19–T82N–R34W; thence curving southeasterly through Section 20–T82N–R34W to the west corporation line of the city of Dedham connecting with an unnamed street.

Dedham:

Beginning at the west corporation line connecting with an unnamed street; thence southeasterly to the south corporation line connecting with an unnamed street.

Beginning again at the south corporation line of the City of Dedham, connecting with an unnamed street; thence in a southeasterly direction through Sections 20, 21, 28, 27 and 26–T82N–R34W to a point approximately 275 feet east of the SW Corner Section 26–T82N–R34W; thence easterly following substantially the section line of Section 35 and

36-T82N-R34W and Sections 31, 32, and 33-T82N-R33W to a point approximately 2,000 feet east of the NW Corner of said Section 33; thence curving in a southeasterly direction through said Section 33 to the west corporation line of the City of Coon Rapids, connecting with an unnamed street.

Coon Rapids:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly to the south corporation line connecting with an unnamed street. (Carroll/Guthrie County line)

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Iowa 141 in Carroll County, Iowa.

Beginning at a point approximately 400 feet east of the SW Corner of Section 16-T82N-R35W; thence curving in a northwesterly direction to a point approximately 400 feet north of the SW Corner of Section 16-T82N-R35W.

East Junction of US 71 and Iowa 141:

Beginning at a point approximately 1000 feet east of the SW Corner of Section 13-T82N-R35W; thence curving in a northwesterly direction to a point approximately 1000 feet north of the SW Corner of Section 13-T82N-R35W.
