

New description – Iowa 161 and its extension in Carroll County described as follows:

Beginning at a point approximately 2,000 feet southeast of the NW Corner Section 20-T82N-R34W (west junction Iowa 141); thence east through said Section 20 to the west corporation line of Dedham, connecting with 4th Street.

Dedham:

Beginning on 4th Street at the west corporation line; thence east on 4th Street to 4th Avenue; thence south on 4th Avenue to the south corporation line.

Beginning again at the south corporation line of Dedham, connecting with 4th Avenue; thence south following substantially the section line of Section 21-T82N-R34W to a point approximately 1,950 feet north of the SW Corner of said Section 21 (east junction Iowa 141).

Due to a review of our Primary Road System records, Iowa 161 in Carroll County should be deleted, and the new description added should be officially included into the Primary Road System.

Iowa 161 begins approximately ¼ mile west of Dedham and travels in an easterly, southerly direction terminating approximately ½ mile south of Dedham, via the City of Dedham, Iowa.

Beginning at the west corporation line connecting with an unnamed street; thence easterly and southerly to the south corporation line connecting with an unnamed street.

Beginning at the west corporation line connecting with an unnamed street; thence easterly and southerly to the south corporation line connecting with an unnamed street.

Beginning at a point approximately 850 feet east of the NW Cor. Sec. 20-T82-R34; thence east 1780 feet to the west corporation line of the Town of Dedham, connecting with Fourth Street.

Beginning again at the south corporation line of the Town of Dedham connecting with Fourth Avenue at a point one-fourth mile south of the NE Cor. Sec. 20-T82-R34; thence south approximately 1972 feet to Primary Road No. 141.

Beginning at a point approximately 850 feet east of the NW Corner Section 20-T82N-R34W; thence east 1,780 feet to the west corporation line of the Town of Dedham, connecting with Fourth Street.

Dedham:

Beginning on Fourth Street at the west corporation line; thence easterly on Fourth Street to Fourth Avenue; thence southerly on Fourth Avenue to the south corporation line. (Note – Iowa 161 is hereby assigned to the above route of former Iowa 141 in Dedham).

Beginning again at the south corporation line of the Town of Dedham connecting with Fourth Avenue; thence south approximately 1,972 feet to Iowa 141.
