Iowa 397 begins on Main Street at the intersection of Tallman Street and travels north and east to Iowa 144.

Transfer of jurisdiction agreement numbers TJ-397-0 (6) --2M-37 and TJ-397-0 (7) --2M-37 between the Iowa Department of Transportation and Greene County and the City of Paton transferred Iowa 397 to local jurisdiction. The present description of Iowa 397 should be deleted to reflect this change.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve deleting the present description of Iowa 397 in Green County and the City of Paton from the Primary Road System.
