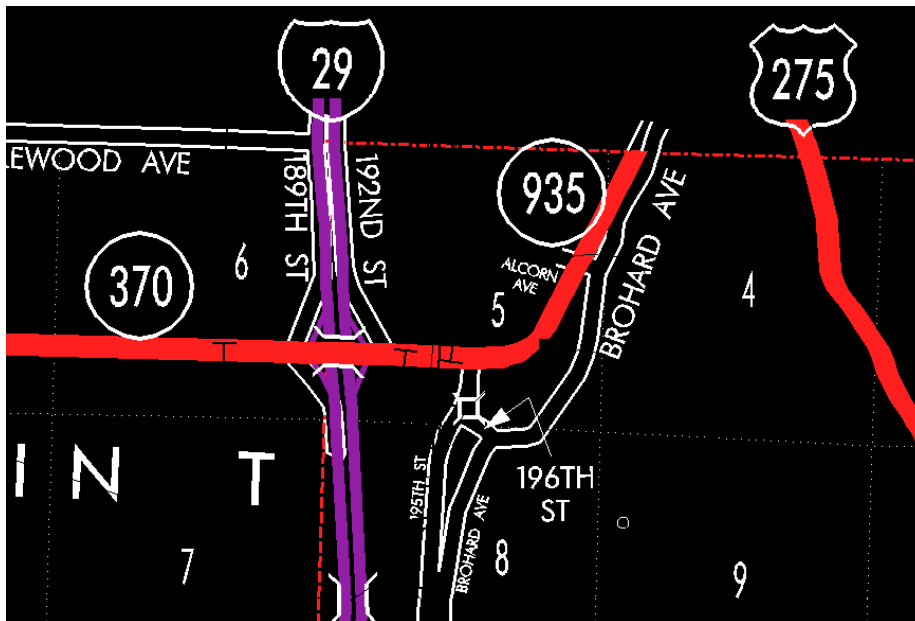

Senate File 451 transferred Unsigned Iowa 935 in its entirety, in Mills County, to county jurisdiction on July 1, 2003.

DISCUSSION/BACKGROUND:

Unsigned Iowa 935 begins on the Iowa–Nebraska State line approximately two miles south of the NW corner of Mills County, and travels generally northeasterly to the Mills–Pottawattamie County line approximately four miles east of the NW corner of Mills County.

To maintain continuity in the primary route numbering system with the State of Nebraska, the portion of Unsigned Iowa 935 in Mills County from the Iowa–Nebraska State line in the SW $\frac{1}{4}$ of Section 11–T73N–R44W northeasterly to the east ramps of Interstate 29 in SW $\frac{1}{4}$ of Section 5–T73N–R43W should be deleted and re-designated as Iowa 370.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of Unsigned Iowa 935 in Mills County from the primary road system and approve including the attached new description of Unsigned Iowa 935 in the primary road system.

Locate Unsigned Iowa 935 in Mills County as follows:

Beginning at a point approximately 350 feet north and 900 feet east of the SW Corner Section 5–T73N–R43W (east ramps of Interstate 29); thence easterly and northeasterly through Sections 5 and 4–T73N–R43W to the Mills–Pottawattamie County line at a point approximately 400 feet east of the NW Corner Section 4–T73N–R43W, Mills County (SW Corner Section 33–T74N–R43W, Pottawattamie County).

DISCUSSION/BACKGROUND:

Transfer of jurisdiction number TJ–370–0(2), between Pottawattamie County and the Iowa Department of Transportation, transferred Iowa 370 in Pottawattamie County to county jurisdiction on October 6, 1980. To maintain continuity in the Iowa route numbering system Iowa 370 in Mills County should be re-designated as Unsigned Iowa 935.

Unsigned Iowa 935 begins on the Iowa–Nebraska State line approximately two miles south of the NW corner of Mills County, and travels generally northeasterly to the Mills–Pottawattamie county line approximately four miles east of the NW corner of Mills County.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve including the attached description of Unsigned Iowa 935 in Polk County in the primary road system.

Locate Unsigned Iowa 935 in Mills County as follows:

Beginning at the Iowa-Nebraska State line; thence in a northeasterly direction through Sections 11, 2, and 1-T73N-R44W to a point near the center of the SW $\frac{1}{4}$ of Section 1-T73N-R44W; thence easterly following substantially the S $\frac{1}{4}$ section line of Section 1-73N-R44W and Sections 6 and 5-T73N-R43W to a point approximately 1350 feet north and 300 feet east of the SW Corner Section 5-T73N-R43W (junction Interstate 29); thence easterly following substantially the S $\frac{1}{4}$ section line said Section 5 to a point in the SE $\frac{1}{4}$ of Section 5-T73N-R43W; thence in a northeasterly direction through Sections 5 and 4-T73N-R43W to a point on the Mills-Pottawattamie County line approximately 500 feet east of the NW Corner of said Section 4-T73N-R43W, Mills County (SW Corner Section 33-T74N-R43W, Pottawattamie County).
